8. Continued discussion regarding a portable Toast POS system to be used with the portable bar. Currently priced on sale/discount. Upon completion of discussion, we agreed to purchase it.
9. The committee discussed the low attendance at the Beach Party and the decision by House Activities to hold the event rain or shine. The Bar and Rental Committee will continue to evaluate whether providing bar service at future Beach Parties is feasible. At this time, the significant effort required to create and operate a bar at Beach 1 does not appear to be financially beneficial.

Several options were discussed for future Beach Parties, including:

- Whether the ballroom should remain available as an indoor backup location in the event of inclement weather.

- Whether a designated rain date should be established.
- Whether a minimum attendance requirement should be implemented, with the understanding that the event may be canceled if the minimum headcount is not met.

These items will remain under review by Bar and Rental as the House Activities committee considers these recommendations for future Beach Party events.

10. All food trucks events were very successful this year.

11. Festival Day alcohol ordering will take place in the coming weeks.
