- Jeff resigned from security staff. Last shift 1/9
- Rich was notified that he continues to miss shifts with no notification to the office. Charlie stated he believes that's incorrect. Will follow up with office
- Committee vote: motion to purchase remaining cameras that were backordered in Dec, NTE \$2500. Vote 8 yes, 3 not eligible
- Committee vote: motion to hire VP Security to install all new cameras in an amount of NTE \$7500, to be paid as each site is done. Vote 8 yes, 3 ineligible
- All WML properties (excluding clubhouse which already has fiber) have been upgraded to Optimum fiber, reducing security budget for internet
- FYI to purchase camera adapters and misc materials for camera upgrades from amazon for approx. \$1300
- Security vehicle repair is complete and is back in service
- Discussion about security vehicle interior not being kept clean by staff
- WML Temple will be advised that going forward, we will require a hold harmless from them, and they will need to have us an additional insured, in order to continue using our parking lot.
- Discussion about being down to only 1 security guard, and the difficulties finding replacements, pay rate, etc. Concerns raised about busy events coming up like pub night, comedy night, etc., where we have a lot of people in the building drinking alcohol. Committee will contact the outside security firm used during Festival Days to see costs to hire one-off guards for these high-profile events.

- All new camera systems are installed except for clubhouse
- There was a wiring issue at beach 1 and beach 3. Both have been resolved.
- Will begin planning/prep for clubhouse shortly
- Short 1 camera (ordering issue) and might need additional hard drive for Beach 1. Should be under motion threshold and will order once we have walkthrough at clubhouse with vendor to make sure we don't need anything else. Will also be adding camera for liquor, and the associated wiring.
- Security incidents already increasing as the weather is getting nicer. Mainly non-residents using the facilities. Incident reports are being submitted.
- Guard schedules finalized and will be making offers to applicants, then advising existing guards about the revised schedules. All guards will need to have SORA training at some point this year. Found online/virtual classes. About \$325 including NJ State Police registration fee of \$100, and fingerprint/background check from IdentiGO for about \$75. We should see if this fingerprint/background check can be waived if Laurie does this already.
- An offer to a potential security guard (retired police officer) was made and accepted. His paperwork is being processed.

7. Will remind security guards to check badges at tennis courts and remove any realtor open house signs on POA property and the Welcome To WML sign
8. Discussed non-residents using beach 3 frequently for fishing.
9. Still having difficulty hiring boat patrol. Steve K. will check if any lifeguards with boaters license would be interested
